During the fiscal year ended June 30, 2015, TWLT purchased 7 parcels throughout Arizona, California, and Oregon for a total of 336 acres. TWLT transferred 23 parcels, a total of 1,241.3 acres located in Arizona, California, Idaho, Nevada, Oregon, and Washington. The Wilderness Land Trust is also working on the preservation of lands in Colorado, Montana, and New Mexico.

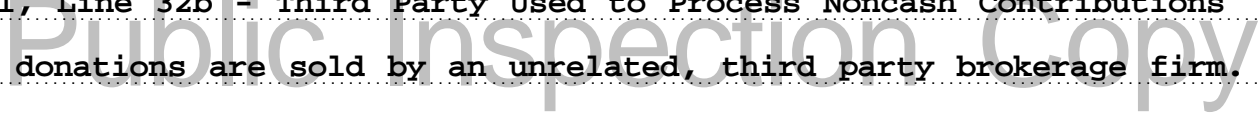
