DURING THE FISCAL YEAR ENDING JUNE 30, 2021, THE WILDERNESS LAND TRUST ACQUIRED 12 PARCELS IN CALIFORNIA, COLORADO, NEW MEXICO AND WASHINGTON TOTALING 667.3 ACRES, AND TRANSFERRED 11 PARCELS IN ALASKA, CALIFORNIA, COLORADO, AND NEW MEXICO TOTALING 1,732.6 ACRES.
